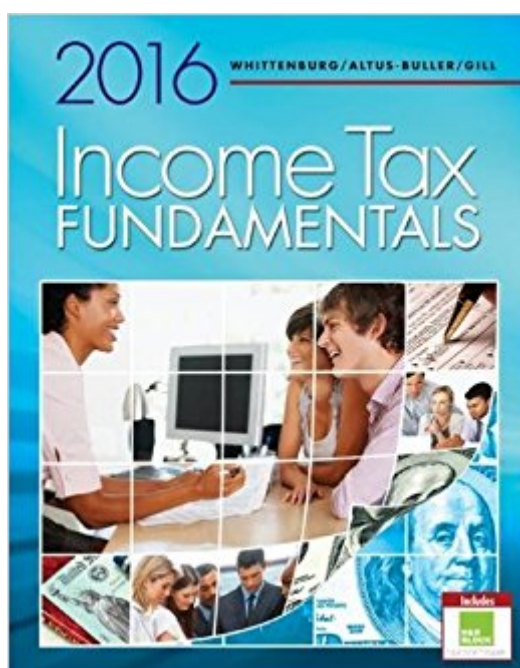

the Charles W. Lamden School of Accountancy at the Fowler College of Business at San Diego State University. Her practical experience includes work as a tax manager for Arthur Young, now Ernst & Young, one of the Big 8 accounting firms at the time.
