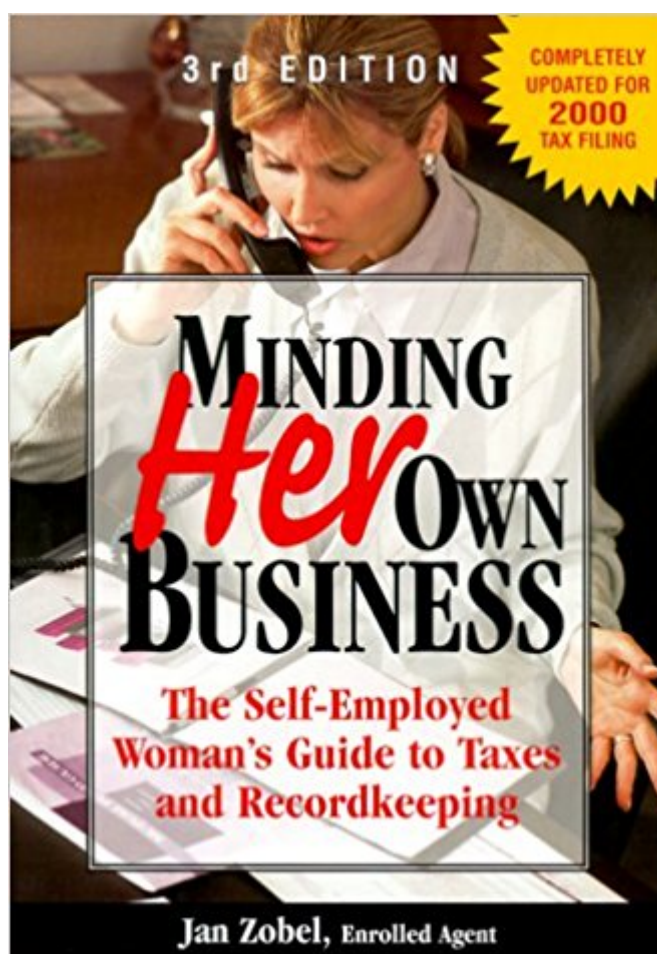

Although this book's title indicates it's for women, the author explains in the introduction that it's really for anyone, particularly those with what she calls "numberphobia".
