

The tbb was clear and well written however this study guide (SG) condensed down the core material in the tbb to about a third the space and in outline form! This SG was not mentioned by the instructor however when I saw it was available inside the cover of the tbb and reasonably priced I thought why not purchase it on ? Due to compressed nature of this course this product proved

invaluable. While other students without the SG first had to condense down the tbb I was already one step ahead and had the condensed version already in front of me to start my study.
