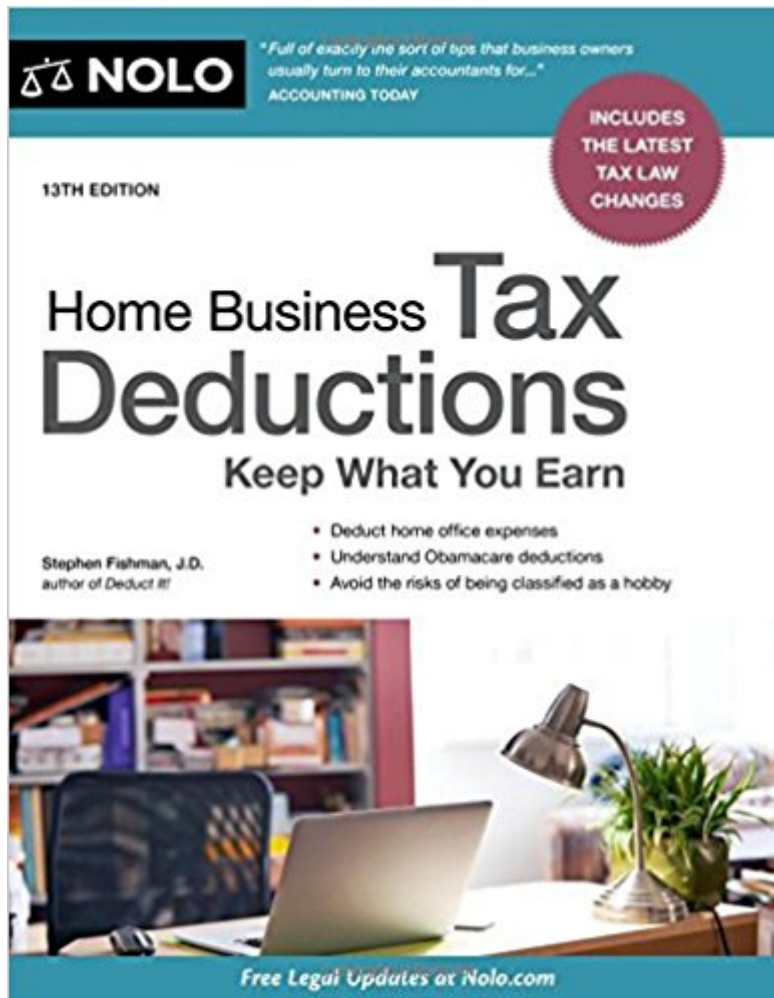

You can buy a book that lists a thousand deductible expenses, but usually you know what you need for your business, and this book tells you how to know if something is deductible by analyzing it the way the

IRS would. Business Taxes based on what the IRS is looking for--also how to set up a business--types of biz (and how that affect taxes). Ideas for accounting & setting up books. Sometimes it's surprising what you CAN deduct and then sometimes it's surprising what you can't. There is now a way to deduct supplies, without accounting for what percentage you've used, and a way to deduct a \$2000 computer or an office desk without using depreciation.
