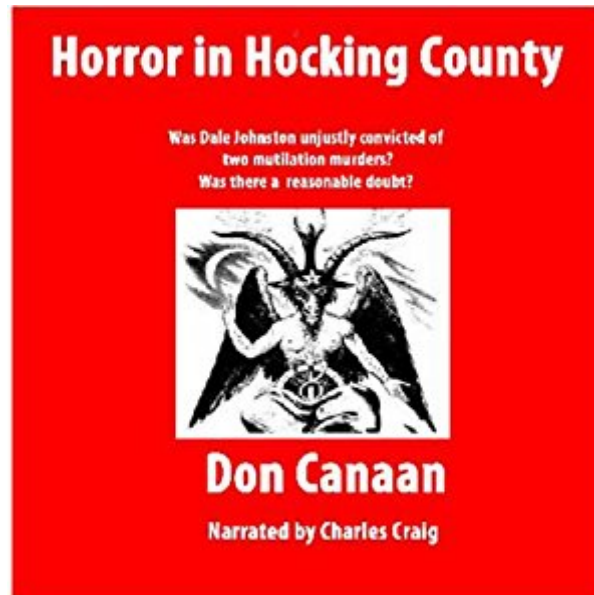

Synopsis

Dale Johnston was arrested, tried and convicted for the dismemberment murders of his stepdaughter, Annette Cooper, and her fiancé, Todd Schultz. He was sentenced to die in the electric chair. His conviction by a three-judge panel was later reversed by the Ohio Court of Appeals and that decision was subsequently upheld by Ohio's Supreme Court. However, the original question still remained: Was there a reasonable doubt?
